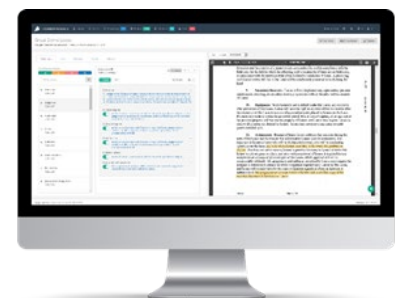

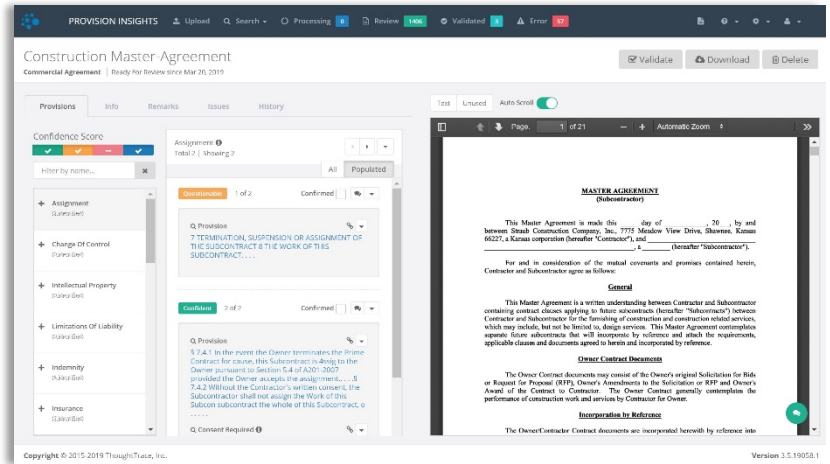

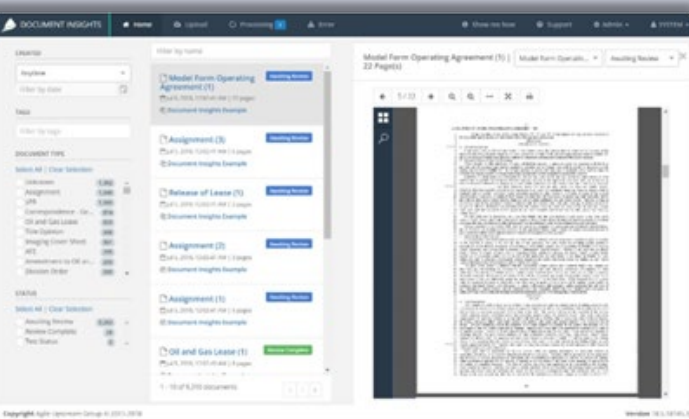
PROVISION INSIGHTS
